CALL FOR APPLICATIONS: IMPROVING COMMUNITY FOOD SYSTEMS

To ensure we are bringing health in reach for all Coloradans, the Colorado Health Foundation (CHF) is opening funding for [Improving Community Food Systems](#), which is designed to support coalitions to develop plans focused on strengthening local food systems. Grant funding is available up to \$85,000.

This funding opportunity will support a nine-month planning process aimed at addressing one or both of the following Colorado Blueprint to End Hunger goals:

- a) Increase the number of Coloradans who can access affordable, nutritious food in their communities
- b) Increase the number of Coloradans who can access food assistance and nutritious food through community-based organizations.

CALL FOR GRANT APPLICATIONS: FARMERS MARKET PROMOTION PROGRAM AND LOCAL FOOD PROMOTION PROGRAM

The U.S. Department of Agriculture's (USDA) Agricultural Marketing Service (AMS) recently announced the availability of \$23 million in grants to support the development, coordination and expansion of local and regional food markets, enterprises and producer-to-consumer marketing. And they're offering webinars to help make it easier for potential applicants!

The Farmers Market and Local Food Promotion Program (FMLFPP), authorized by the 2018 Farm Bill under the Local Agriculture Marketing Program (LAMP), covers both the [Farmers Market Promotion Program \(FMPP\)](#) and [Local Food Promotion Program \(LFPP\)](#).

FMPP funds projects that develop, coordinate and expand direct producer-to-consumer markets to help increase access to and availability of locally and regionally produced agricultural products.

LFPP grants support the development and expansion of local and regional food business enterprises to increase domestic consumption of, and access to, locally and regionally produced agricultural products, and to develop new market opportunities for farm and ranch operations serving local markets. Both have a three-year performance period.

Funding ranges from \$50,000 to \$500,000. Applications are due June 18th, 2019. Applications for both FMPP and LFPP must be submitted electronically through www.grants.gov by **11:59 p.m. Eastern Time on June 18, 2019**.

CALL FOR APPLICATIONS: COLORADO TOURISM LEADERSHIP JOURNEY CLASS OF 2020

The Colorado Tourism Leadership Journey, a professional development and networking opportunity for those with any ties to tourism (City, County, State and Federal Government, Ski, Hotel, Restaurant, Gaming, Agritourism, Media/Marketing/Advertising, Charitable/Social Organizations, and beyond), aims to create benefits not only for participants but for employers and industry as a whole. For employers, it's a cost-effective way to develop, reward and retain top talent. For the state, it aims to strengthen our competitive advantage by developing a high-performing, more unified tourism industry that will be even better equipped to serve as one of Colorado's leading economic drivers.

This one-year program will begin and conclude at the annual Colorado Governor's Tourism Conference and encompass:

- Attendance at two successive Governor's Conferences;
- Three experiential learning opportunities spanning three days (half day, full day, half day) at locations around the state;
- Periodic one-hour check-in meetings with small groups;
- Required readings of up to five texts;
- Regular encounters with assigned mentors; and
- Completion of an Action Learning Project.

CALL FOR APPLICATIONS: CRAFT STUDIO 201

Part of OEDIT's Rural Technical Assistance Program, CRAFT Studio 201 provides customized support for communities or regions wishing to advance a specific tourism-related goal or strategy.

The duration of this course is 100 hours, usually completed in 6-8 months. CTO recommends that groups of tourism partners within a community or region with identified tourism assets and promotional strategy, with 1-2 local champions to be the point of contact for CTO. CSU is happy to be on the planning team, but the champions should be located and significantly involved in the community. After successful completion of CRAFT Studio 201, participating communities or regions are eligible to apply for funding to implement a key priority determined during the program. Up to \$7,500 is available for a CRAFT Studio 201 Implementation Grant. Potential outcomes of CRAFT Studio 201 include increased visitation to region or destination, increased awareness of region or destination, and creation of a plan for development or promotion of a region or destination.

Requirements to participate:

- Local, engaged leaders committed for one year to accomplish the goal of this initiative;
- Strong, demonstrable community buy-in;
- Clearly developed measurements for success and reporting capabilities;
- Applicants must be currently engaged with tourism on some level.
- If you are not directly employed by or provide services to the tourism industry below are additional qualifications:
 - Attendance at a Colorado Governor's Tourism Conference;
 - Attendance at a Colorado regional tourism conference;
 - Participation in Colorado.com; and
 - Member of any tourism-related association.

Rural Technical Assistance Program (RTAP), formerly Colorado Blueprint 2.0, is a series of technical assistance initiatives offered by the Colorado Office of Economic Development to enhance rural economic development strategies across the state. The program leverages state partnerships and specialized resources to address the unique economic development goals of rural Colorado. This

community-driven effort turns regional feedback on local economic needs into a catalyst for economic growth.

CALL FOR APPLICATIONS: AGRICULTURE AND FOOD RESEARCH INITIATIVES

The Agriculture and Food Research Initiative (AFRI) is America's flagship competitive grants program that provides funding for fundamental and applied research, education, and extension projects in the food and agricultural sciences. In this RFA, NIFA requests applications for six AFRI priority areas through the Foundational and Applied Science Program for FY 2019 and FY 2020. One of the program priority areas is Agricultural Economics and Rural Communities (AERC). The program area supports rigorous economic and social science research that informs decision making, policy design, and implementation to enhance the sustainability of agricultural production systems and natural resources, promote rural economic development and prosperity, enhance quality of life, and alleviate poverty. Topical issues include, but are not limited to, examining agricultural markets and international trade; commodity policy, crop insurance, and policy design and impact; market structure and performance in the food system and value chain; interactions between agriculture and the environment; rural economic development and well-being; food security; consumer preferences, behavior and market development; and decision-making under uncertainty.

Each application must address at least one of the five program area priorities listed below. Details about each of the AERC program areas are provided later in this section.

- a) Small and Medium-sized Farms
- b) Economics, Markets and Trade
- c) Social Implications of Food and Agricultural Technologies
- d) Environmental and Natural Resource Economics
- e) Rural Economic Development

Requested Project Types: Research Projects or Integrated (research with education and/or extension) Projects only

Requested Grant Types: Standard, Conference, and Food Agricultural Science Enhancement Grants only

Letter of Intent: Required only for Conference Grant applications. The LOI must be submitted a minimum of 135 days before the conference begins.

Application Deadlines:

- Fiscal Year 2019: Thursday, July 19, 2019 (5:00 p.m. Eastern Time)
- Fiscal Year 2020: Thursday, March 5, 2020 (5:00 p.m. Eastern Time)
- Conference Grants: submitted after LOI decision response and a minimum of 90 days before the conference begins

Learn how to safely produce food from home for a cottage food business. Courses cover a variety of topics that include but are not limited to:
