#### **About Kateri**

## **Role Description**

We are looking for someone who is excited about bringing positive change to rural communities through investments into regenerative agriculture.

This role will serve as a technical advisor to our ranches to help develop rotational grazing plans and ranch plans that factor in water, biodiversity, forage, ranch profitability, and other key factors. We are looking for someone who is comfortable working with ranch hands, ranch managers, and landowners to create a customized ranch plan focused on regenerative outcomes and increases soil carbon sequestration.

Our average ranch is 15,000 acres and we have customers in every state west of the Mississippi, so we are looking for someone who can work at a large scale and also has experience adapting plans to different climates and environments.

This can be a full-time or part-time role depending on the candidate and their existing responsibilities.

## **Key Duties**

- Build annual or seasonal grazing plans for a variety of ranches
- Establish proper vegetation and forage inventories based on ranch site visits
- Review and refine any grazing plans that we create through contractors
- Work with our R&D teams to help translate results from all of our data collection to ranchers
- Serve as a point of contact to answer rancher questions on best practices
- Ensure ranchers are able to execute on their grazing plans
- Help us identify the best areas to invest in ranches (perennial seeding, water infrastructure, etc.)
